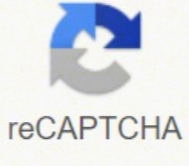




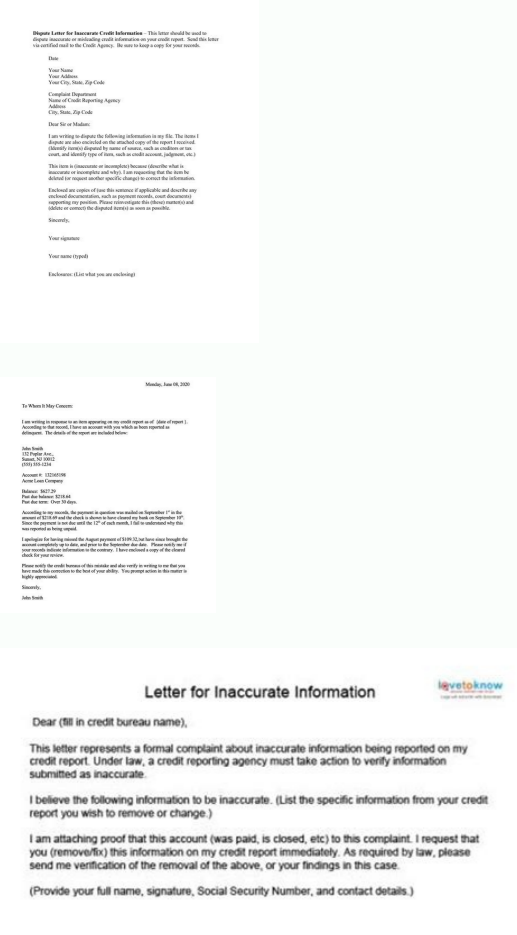

Unlike a dispute, the creditor has no obligation to take any action in response to a goodwill letter or assist your credit repair efforts. Jun 10, 2021 · The credit bureau involved must provide you with results of the investigation in writing and also a free copy of your credit report if the dispute results in a change to that report. The credit bureau must also provide you with the name, address and phone number of the furnisher that reported the incorrect information.
